

SAFE AND SOBER PROJECT GRADUATION PETALUMA HIGH SCHOOL

GUIDELINES AND CONTRACT

- 1. The Project Graduation Party is for the current members of the class of 2019 of Petaluma, Carpe Diem, San Antonio and Valley Oaks High Schools only.
2. Students will be required to show Photo ID to gain admission (photocopy of driver's license is recommended). Students will be asked to remove hats, outerwear, shoes or boots and understand that they may not enter with a backpack or purse or other item in which to carry personal possessions. There is a secure room in which students can store personal items. All students and items are subject to search.
3. The possession or influence and/or use of drugs or alcohol by any attendee, graduate, senior, party staffer or entertainer are not permitted. Parents/Guardians may be contacted if your student is suspected of being under the influence of alcohol or drugs and may be asked to come pick up the senior. The senior may be held in an area separate from the party for observation. The senior may, at the discretion of Project Graduation, be allowed to join the party. If Project Graduation feels the student should be sent home, ONE attempt will be made to reach the parent/guardian at the phone number listed on this form. If we cannot reach the parent/guardian at the phone number provided, we reserve the right to call the police or ambulance for emergency assistance depending on the severity and/or condition of the student.
4. We will contact the parents/guardians of graduates/seniors who purchased a reservation but have not checked in within one hour of the latest check in time of the party at the phone number provided on the permission form.
5. Parents or Guardians of graduates will be called to pick up their student if the student wishes to leave the party before the designated end time. Only the student of the parent/guardian will be allowed to leave with the parent/guardian. Students may not leave the party before it ends unless they are accompanied by their parent/guardian. No more than one student will be allowed to leave with a parent.
6. Students leaving the party will not be readmitted.
7. Students must be present to win prizes at the end of the party.
